#### DRAFT FORMAT FOR THE NATIONAL REPORTING MODULE ON THE IMPLEMENTATION OF THE AEWA PLAN OF ACTION FOR AFRICA

#### Introduction

The second <u>AEWA Plan of Action for Africa (PoAA)</u> which covers the period 2019-2027 was adopted by <u>Resolution</u> 7.1 of the 7<sup>th</sup> <u>Meeting of the Parties (MOP7) to AEWA</u> (South Africa, December 2018). It outlines concrete actions and processes to be conducted by different actors, including the AEWA African Contracting Parties, at both national and international level, in order to implement the AEWA Strategic Plan 2019-2027 in the African region.

AEWA Resolution 7.1 also instructs the AEWA Standing Committee (StC), working with the Technical Committee (TC) and the Secretariat, to establish a module on the implementation of the AEWA PoAA 2019-2027 in the national report format and to integrate the module in time for reporting to MOP8. The PoAA reporting module complements the general National Reporting on the implementation of AEWA in the African region. Its purpose is to obtain feedback on the delivery of those actions and processes outlined in the AEWA PoAA which are under the lead responsibility of the AEWA African Contracting Parties. The format for the module on reporting on the implementation of the AEWA PoAA for the period of 2019-2020 was developed by the AEWA Secretariat, reviewed by the AEWA Technical and Standing Committees and approved by the Standing Committee for establishment of the online PoAA reporting module to AEWA MOP8.

The format for the module on reporting on the implementation of the AEWA PoAA for the period of 2021-2024, has been developed by the Secretariat based on the MOP8 PoAA reporting template, to cover PoAA obligations scheduled to be delivered during the period of 2021-2024. Actions and processes scheduled to be delivered beyond MOP9 are not taken into account but will be captured for reporting to MOP10.

The draft MOP9 PoAA reporting format was submitted to the 16<sup>th</sup> Meeting of the AEWA Technical Committee (January 2021) for review and comments and was subsequently posted on the TC workspace in March 2021 for further review. The revised draft of the document reflecting the resulting inputs from the TC consultation process was submitted to the 16<sup>th</sup> Meeting of the AEWA Standing Committee (StC16) in May 2021 for review and consideration for approval. In the absence of any immediate comments from StC16, an additional two-week review period was accorded for any subsequent comments from the StC. In the absence of any further comments from the StC during the supplementary review period accorded by StC16, the current draft of the document which includes additional adjustments to the structure/format based on lessons learned from the analysis of the MOP8 PoAA National Reports, was submitted to 18<sup>th</sup> meeting of the Standing Committee (28 July 2021, in virtual format) for consideration, and was approved for submission to MOP8. Following adoption of the MOP9 PoAA reporting format by MOP8, it would be translated by the Secretariat into the online reporting template within the CMS Family Online Reporting System, on time for reporting to MOP9.

#### Action Requested from the Meeting of the Parties

The Meeting of the Parties is requested to review and adopt the final draft format for National Reports on the implementation of the AEWA Plan of Action for the period of 2021-2024, for use the MOP9 reporting cycle
