**REPORT ON THE IMPLEMENTATION OF THE AEWA INTERNATIONAL
IMPLEMENTATION PRIORITIES PLAN 2006-2008**

INTRODUCTION

The implementation of the AEWA International Implementation Priorities for 2006-2008 and the previous years is fully dependent on voluntary contributions from Contracting Parties. Since MOP3, approximately €680,000 has been accrued and was partly allocated to the implementation of the IIP. Although the Secretariat is very grateful for the amount received it should be noted that for the full implementation of IIP '06-'08, a total amount of €5,2 million would be needed.

The Secretariat notes that most Parties are facing the effects of the economic recession on their budget. In the second half of 2006 the implementation of the African-Eurasian Flyways GEF project has begun; this is increasing the pressure on the Secretariat to fundraise for projects that are part of the IIP 2006-2008 as well as of this GEF project. A total amount of around €1 million is needed relatively short-term to ensure full implementation of the GEF project. The Secretariat will therefore increase its efforts to accrue the necessary funds.

	<ul style="list-style-type: none"> This Darwin-funded project was launched in April 2006. It contributed significantly to understanding breeding ecology of the species and its breeding distribution. The project resulted in a new population assessment, which is higher than the historically lowest estimate noted in the AEWA SSAP of 2002. Satellite tagged birds helped to reveal migration routes and wintering grounds of the western breeding population. This also helped to identify staging areas in Turkey (and in Syria) where approx. 3,000 migrating individuals were observed. AEWA provided additional funds for additional satellite tags and field work in the next post-nuptial season. Additional funds were acquired by RSPB with the support of AEWA for satellite tagging of birds from the eastern breeding population, which presumably winter in India.

- Unfortunately the incumbent decided to step down mid 2007 but will continue to work on some issues until a successor is recruited and enters on duty. New recruitment will take place before mid-2008.

Red-breasted Goose*Coordination of the implementation of the Red-breasted Goose SSAP*

- In 2006 a full-time coordinator for the Red-breasted Goose SSAP was recruited.

- Simultaneous winter counts were coordinated to produce population estimates
- A SSAP revision workshop is taking place at the end of February 2008
